<u>A motion was made by Windham, seconded by Smith to accept the Minutes of the December 11, 2012</u> Planning Commission Meeting. The Council vote was unanimous.

Planning Commission member, Patsy Burke stated there was no news to report.

CITIZENS COMMENTS/CONCERNS:

LaTrelle Oliver extended an invitation for all to attend the Arbor Day celebration at City Hall on February 16, 2013 at 10:00 A.M. There will be a presentation by Cousin Middle School students. Bob Swanson owner of Specimen Tree Inc. will be the guest speaker. Mr. Swanson will demonstrate air spading and planting of trees. There will be a tree owner's manual given to each household in attendance.

Virgil Eady announced the Oxford Historical Cemetery Foundation will hold its annual meeting on Sunday, February 10, 2013 at 2:00 P.M. at City Hall. He extended an invitation for anyone interested in participating in the activities of the foundation to attend.

MAYOR'S REPORT

Mayor Roseberry announced he received notice that DCA (Department of Community Affairs) has accepted the city's Short Term Work Program which the council will adopt at the April meeting.

Mayor Roseberry distributed an outline summary pertaining to the State open meeting requirements and ask council to review it for discussion at the February 18, 2013 work session.

The mayor also announced that Newton County has adopted an ordinance prohibiting smoking at all County community parks. He suggested this be discussed as a possibility of adopting this policy for parks in Oxford.

Mayor Roseberry presented a Proclamation to Ms. Patsy Burke as the Honorary Councilmember for the City of Oxford for the month of February 2013. Ms. Burke is the first citizen to be nominated for this position as a result of a Resolution passed by council at the January 7, 2013 Mayor and Council meeting. This program is designed to encourage citizen participation in our governing body. Ms. Burke was escorted by City Manager, Bob Schwartz and Police Chief, Dave Harvey on a tour of the city. She also spent time with each department learning the day to day operations of the city.

Bob Schwartz/City Manager

City Manager, Bob Schwartz announced that Planning Commission members Mike Ready, Vivian Harris and he will be attending a class for planning administrators in Atlanta.

City Attorney/David Strickland No report

George Holt Finance/Oversight/Personnel

A motion was made by Holt, seconded by Smith to authorize the city to pay the 2% increase in FICA on behalf of the city's full time employees from February 2013 through June 2013 and will amend the FY2013 budget to increase the salaries account for the city clerk's department by \$1,700 and to reduce the overtime account for the city clerk's department by \$1,700.00. The council vote was unanimous.

A motion was made by Holt, seconded by Smith to authorize the City Clerk and Treasurer to write off \$105,462.79 in uncollectible bad debts that have accumulated from 2008 to December 31, 2012 and to make all appropriate adjustments to the city's general ledger. The council vote was unanimous.

Council member Holt presented the first reading of three Ordinances to approve several technical corrections in the City Code relating to purchasing and the writing of checks.

- i. An Ordinance to Amend Chapter 4 Revenue and Finance, Article III budget, By Amending Section 4-318 Transfer of Appropriations.
- ii. An Ordinance to Amend Chapter 4 Revenue and Finance, Article III Budget, By Amending Section 4-318 Amendments.

iii. An Ordinance to Amend Chapter 4: Revenue And Finance; Article V: Centralized Purchasing Sections 4-502, 4-503, 4-504, and 4-505.

A motion was made by Davis, seconded by Holt to accept the recommendation of the Planning Commission and adopt a resolution to rezone the Elizer property (parcel X0050-00000-015-000) from R-20 to RR – Rural Residential. The council vote was five (5) in favor with council member Lyn Pace abstaining and council member David Eady not present.

Terry A. Smith Utilities/Public Works No report

A motion was made by Smith, seconded by Holt to adopt a resolution to authorize a \$0.011382 kWh increase in the Power Cost Adjustment and to authorize a "Cost of Service" study for both the electric fund and the water and sewer fund by Electric Cities of Georgia. The council vote was unanimous.
